ABSTRACT

TAMIL NADU GOVERNMENT SERVANTS' FAMILY SECURITY FUND SCHEME - Lumpsum amount payable in case of death of Government servant while in service - Enhancement from Rs.1,50,000/- to Rs.3,00,000/- - Orders - Issued.

ORDER :

The Tamil Nadu Government Servants' Family Benefit Fund Scheme, subsequently renamed as Tamil Nadu Government Servants' Family Security Fund Scheme was launched with effect from 1-1-1974, as a self insurance scheme without involving Life Insurance Corporation of India to support the family of Government employees including those in temporary and non-pensionable service, persons in foreign service and on deputation (menials paid from contingencies) and persons borne on provincialised work-charged establishments and All India Service Officers belong to Tamil Nadu cadre, who die in harness. The subscriber's contribution under the scheme was initially fixed at Rs.10/- p.m. deducted from the pay bill. The lumpsum amount payable in the case of death of the subscribers while in service was fixed at Rs.10,000/-

2. The monthly contribution and lumpsum amount payable under this scheme were revised from time to time. In the Government Order second read above, it was ordered to deduct a sum of Rs.30/- p.m. as subscribers' contribution and to pay a sum of Rs.1,50,000/- as lumpsum amount in the event of death of the Government servant under this scheme.

3. The Hon'ble Chief Minister of Tamil Nadu has made an announcement under Rule 110 of Tamil Nadu Legislative Assembly Rules on 19-02-2016 to enhance the lumpsum amount payable under the above scheme to Rs.3,00,000/- and to deduct Rs.60/- per month towards subscription from the salary of the Government employees.

4. Accordingly, the Government issues the following orders:-

- (i) The lumpsum amount payable under Tamil Nadu Government Servants' Family Security Fund Scheme shall be enhanced to Rs.3,00,000/- This shall take effect from 1-2-2016.
- (ii) The employees contribution under this scheme shall be enhanced to Rs.60/- p.m with effect from February 2016 and this nominal deduction of Rs.60/- p.m. will continue till the superannuation of the Government Servants.
- (iii) The existing rules and other instructions governing the Tamil Nadu Government Servants' Family Security Fund Scheme shall continue..

ABSTRACT

MEDICAL AID – NHIS for employees of Government Departments, Local Bodies, State Public Sector Undertakings, Statutory Boards and State Government Universities, etc., – Continuance beyond 30-06-2016 – Orders Issued.

ORDER :

In the Government Order first read above, orders were issued to provide cashless health insurance cover to the employees of Government Departments, Local Bodies, State Public Sector Undertakings, Statutory Boards and State Government Universities and family members of such employees with a provision to avail assistance upto Rs.2.00 lakh in a block period of 4 years.

2. In the Government Order second read above, orders were issued to implement the scheme through the Star Health and Allied Insurance Company Limited with employee subscription of Rs.25/- per month and insurance premium of Rs.495/- per employee per annum excluding Service Tax. The scheme launched on 11.06.2008 was in operation till 10.06.2012.

3. In the Government Order third read above, orders were issued extending the New Health Insurance Scheme beyond 10.06.2012 and to implement New Health Insurance Scheme, 2012 with enhanced limit of assistance of Rs.4.00 lakh per family for a block of 4 years.

4. In the Government Order fourth read above, sanction was accorded for providing health care assistance by way of reimbursement to Government employees and their eligible Family Members during the period from 11-06-2012 to 30-06-2012.

5. In the Government Order fifth read above, orders were issued to implement the New Health Insurance Scheme 2012, through the United India Insurance Company Limited, with employee subscription of Rs.150/- per month and insurance premium of Rs.1860/- per employee per annum excluding Service Tax, in a block of four years from 01.07.2012 to 30.06.2016. The medical assistance was enhanced to cover 54 new medical treatments and 7 additional surgical procedures under the NHIS, 2012.

6. In the Government order sixth read above a Consolidated List of Hospitals covered under the NHIS, 2012 was notified. The Consolidated List of Hospitals was updated from time to time and last updation was ordered in the Government Order seventh read above.

7. The Government has examined the extension of New Health Insurance Scheme, 2012 beyond 30.06.2016 and decided to extend the same. Accordingly the Government direct that the Health Insurance Scheme, 2016 be implemented from 01.07.2016 as detailed below:-

- (i) New Health Insurance Scheme 2016 shall be implemented with effect from 01.07.2016 for a further block period of four years;
- (ii) A suitable Health Insurance Company shall be selected through National Competitive Bidding by restricting the Bidding to Public Sector Health Insurance Companies as was done in New Health Insurance Scheme, 2012;
- (iii) The Insurance Premium for the above scheme shall be fixed on the basis of rate finalized through the abovesaid competitive bidding;
- (iv) The monthly subscription to be recovered from the employee shall also be fixed based on the insurance premium payable to the insurance company;
- (v) The present limit of assistance of Rs.4.00 lakh for a block of 4 years per family shall be continued. However, the limit on assistance shall be enhanced to Rs.7.50 lakh for a block of 4 years per family for specified illnesses like cancer, liver and other transplantations, etc, to be specified in the covered illness list.
- (vi) The list of hospitals, treatments/surgeries covered under NHIS, 2012 shall be continued under the NHIS, 2016 and additional hospitals and treatment / surgeries shall be included as and when necessity arises;

- (vii) The orders on further modalities, terms and conditions for the implementation of New Health Insurance Scheme, 2016 shall be issued separately.
